# **Challenge Quilt**

"A Yarn Runs Through It"

Each entrant will receive a one yard length of yarn which needs to be incorporated into their quilt.

The quilt may be any type that you choose – applique, landscape, a pattern that you currently have, etc.

The requirements are:

- The finished size needs to be 18" x 18"
- The yarn must enter on the left side of the quilt at any point and exit on the right side of the quilt at any point.
- Each quilt must have a 4 ½" hanging sleeve on the back.

Then she showed her own twist on the block. Many of her wall hangings that she showed were part of challenges at the Pacducah Quilt Show.
- Show and Tell

- Pam read thank you notes from the following: Lindy Backus's family, Camp Tapawingo for our donation and our Camp Quilt weekend, and Ascend for the quilts donated to them.
- Secretary's report: Motion was made by Jenny Martin and seconded by Bonnie Loeh to accept the minutes as they appeared in the newsletter. Motion accepted.
- Treasurer's report: Motion was made by Chris Bauknecht and seconded by Mary Kay Burish to accept the treasurer's report as R appeared in an email. Motion accepted.

# June 9th 2022 Meeting Minutes - Continued

- June is the last meeting for the year and officers with terms ending were recognized. VP Julie Klumpp (who is returning as VP), treasurer Kathy Gurtaski, and members at large Bonnie Loeh and Betty Schwede.
- Mystery quit update: The final step is in the June newsletter. Ellen Buck and Linda Londo showed their mystery quilts.
- Fall Camp: Julie shared that this fall it will not be an overnight camp. Cost is a factor. Camp will be open from 8a.m. 8p.m.. Julie is going to check if we can extend the time one hour at each end of the day.
- Show update: Patty Angoli shared that the quilt shows featured quilter will be chosen by the guild as a whole. Slips of paper were handed out and members were asked to write who they would like to nominate for featured quilter. Patty will contact nominated to see if they are interested. Featured quilter will be voted on at the September meeting. Patty also presented the Quilt Show budget. Kay Olker made a motion to accept the budget, Bonnie Loeh seconded it. Budget approved.
- Gift Boutique: Bonnie and Mary Kay handed out a suggested list of items that can be in the gift boutique.
   The guild receives 10% of the items sold.
- Charity Raffle: Par picked up baskets that can be used for the basket raffle.
- President's Challenge: Pam is asking members to make a quilt of honor for a veteran. They will be hung at the show and presented to a vet on Sunday afternoon. Quilts will go to local vets.

- Guild Picnic: August 11" at Ascend.. Email Pam if you are able to help with the picnic.


# June 9th 2022 Meeting Minutes - Continued
