September 10, 2020 - Guild Meeting Minutes

Meeting called to order at 6:45pm by President Lindy Backus.

Pledge of Allegiance was said by all attendees.

Treasurers Report: was reported on by treasurer Kathy Guralski, motion was made by Bonnie Leoh and seconded by Chris Bauknecht. Motion carried

Secretaries Report: not given due to last meeting was in March, 2020 due to Covid 19, and taken by a different secretary and printed in newsletter

Pillows & pillow cases were brought in by many members for InCourage organization.

Show and Tell items were shown by members.

September 10, 2020 - Guild Meeting Minutes - continued

Quilt of Valor -Round Robin was explained by Sue DuPont, and there is much interest in continuing with this project. She is contacting Amvet organization to help with distribution of quilts to veterans.

Also need for more masculine pillowcases to present to servicemen. They have enough feminine pillow cases at present. These pillowcases do not or should not be in Red, white and blue. Sue will put an article in newsletter explaining again the Round Robin technique for those who want to participate this year.

Storage shed: Lindy noted there are more totes in there with Charity Fabric in them. Many are large pieces or partial bolts which can be used for backings.

Also counted about 100 christmas stockings. . Need feedback on possible locations that may need Christmas stockings and amount for each location so more can be made if needed.

Quilt Show discussion: Julie Puestow present as Quilt show committee chairperson. Read email from Show committee and decision to be made in January 2021, to have show or not. Discussion held with membership.

Informed of Raffle Quilt committee's request to only raffle Quilt if it would be displayed at Quilt show. Information of obtaining Raffle license and printing of tickets after obtaining license would give us very little time to sell tickets to family and friends. Statistics of money made at last show from ticket sales of over \$2000.00 but only \$363. Sold at quilt show itself.

Another discussion brought up that member stated she would help behind the scenes in the set up of the show, but she would not work during show. Raising of hands for volunteers willing to work the show and those not willing. Greater majority of the 25 people present would not work at the show due to Covid. Membership recommended Quilt show chairs speak with their committee chairs and members to see how many will still work at the show. Most volunteers had signed up prior to outbreak of pandemic. Also membership worried about a very low attendance of paying customers during these times. Quilt show committee Chairpersons to report back to Board meeting scheduled just prior to Guild meeting on Thurs. October 8,2020

Motion to adjourn at 7:55pm made by Sue Marquardt and seconded by Joan Behnke. Motion carried.
